## MERCHANT MARINE CIRCULAR MMC-245

**To:** Owners/Operators, Company Security Officers, Legal Representatives of Panamanian Flagged Vessels, Panamanian Merchant Marine Consulates and Recognized Organizations (ROs).

**Subject:** Armed Security Personnel on board Panama flagged vessels transiting High Risk Areas.

**Reference:** Law No. 78 of November 15th, 2010 SUA 2005 and SUA PROTOCOL.

1. This Merchant Marine Circular supersedes and compiles **MMC-228; MMC-231; MMC-234; MMC-286** and **MMC-306**.

### 2. Purpose:

The purpose of this circular is to list the private security companies authorized by the PMA to provide the service of armed personnel on board Panamanian-flagged vessels, as well as the recommendations and policies that those companies must comply with during their accreditation.

### 3. Scope:

3.1 This Merchant Marine Circular applies to all Panamanian-registered vessels that hire security companies to provide protection during transit through high-risk areas.

### Background:

3.2 The International Maritime Organization (OMI) issued Circulars MSC.1/Circ.1405/Rev.2 and MSC.1/Circ.1406/Rev.3 both of September 16, 2011, which established interim Recommendations for the ship-owners, owners and flag states regarding the use of Private Security Companies on board the ships, with the objective of give protection to the vessels that sail within high risk areas from the piracy attack and armed robbery.

### 4.1. Authorized Private Maritime Security Companies by PMA.

**4.1.1** The Maritime Safety Committee at its 89th Session approved the Interim recommendation regarding the use of Privately Contracted Armed Security Personnel (PCASP) on board ships in the high risk area as per the MSC.1/Circ.1405/Rev.2, MSC.1/Circ.1406/Rev.3 and MSC.1/Circ.1443 (for reference visit Maritime Security link, (IMO Documents)). All ship-owners and ship-operators when entering into a contract with a PMSC should ensure compliance with the MSC.1/Circ.1405/Rev.2.

#### 4.1.2 Definitions:

- a) High Risk Area: An area as defined in the Best Management Practices version 5 (BMP5) unless otherwise defined by the flag State.
- b) Private Maritime Security Companies (PMSC): Private contractors employed to provide Security Personnel, both armed and unarmed, on board for protection against piracy.
- c) Authorized Private Maritime Security Companies: Private contractors duly recognized by this Administration according MMC-243 to offer their services as Privately Contracted Armed Security Personnel on board Panamanian flagged vessels transiting High Risk Areas.
- d) Team Leader: Person responsible for all aspects of the security team members and who takes care of the storage and handling of fire arms and ammunitions.
- e) Bilateral Agreement: These are contractual agreements between the Ship Operator/Owner and the PMSC, stating terms and conditions of the security services.

**4.1.3** The use of PCASP should not be considered as an alternative to Best Management Practices version 5 (BMP5) and other protective measures. It is recommended that BMP be applied throughout the High Risk Area (HRA) and in the Internationally Recommended Transit Corridor (IRTC) and be considered as the first, minimum, preventative option. Placing armed guards on board as a means to secure and protect the ship and its crew should only be considered after a risk assessment has been carried out.

4.1.4 The Panama Maritime Authority has recognized the following companies as PMSC which are authorized to grant the use of security, armed or unarmed personnel on board the Panamanian flag vessels to transit exclusively in High Risk Areas, which are described in our MMC-230:

**4.1.5** Any Private Security Company duly authorized by this Administration and posted in this Merchant Marine Circular, may only request transit authorizations with the name in which the company has been authorized, therefore, the contract that must be attached as part of the pre-established requirements, also the application must have the seal and name approved in this circular. This Administration will not approve any authorization with a change of name, which is not previously authorized by this Administration.

**4.1.6** From October 3rd, 2016, the online application for the Letter of Authorization (LOA) will be available on the website link: <http://certificates.amp.gob.pa/certificates>, also for Navy Authorization on board. Only for cases in which a Port Authority requires so, this Administration will issue an authorization after receiving the following documentation:

- a. Bilateral Agreement signed by the parties with the company stamp.
- b. Passport copies of the guards that will embark the vessel for the specific transit.
- c. In case of weapons Annex, you must attach Annex A of the contract or a company document that describes the weapons, the number of the series and the amount of ammunition.

Unless a Port Authority requires so, the Authorized Private Maritime Security Companies listed above, may proceed without the need of an authorization issued by the Flag State.

The information submitted by the applicant through the above-mentioned website link, should be accurate to avoid mistakes.

**4.1.7** This Administration encourages all the Private Maritime Security Companies which do not require authorization from the Flag State, to notify in advance the geographical position (latitude and longitude) of the boarding and disembarkation of the security personnel, this notification should be done through a message to the following e-mail address [asp@amp.gob.pa](mailto:asp@amp.gob.pa).

The only purpose of this notification is to keep the internal records of this Administration duly updated.

**4.1.8** As of January 1, 2023, the high-risk area of the Indian Ocean has been excluded, as a result of the decrease in piracy cases in that area, however, this Administration will continue to evaluate the behavior after its exclusion, so all the recommendatory measures for Panama registered vessels that transit such area, which is posted in our Merchant Marine Circulars, so it will remain at the discretion of the owner/operator of the ship, after carrying out the risk analysis, the use or not of security companies that provide the service for armed personnel.

## **4.2. Interim Recommendations for Panama flagged vessels using PCSAP while arriving, staying and departing from International Ports.**

**4.2.1** All the Panama Flagged vessels that use PCASP should take in account the guidelines established by the International Maritime Organization (IMO), MSC.1/Circ.1408/Rev.1, "Interim Recommendations for Port and Coastal States regarding the use of privately contracted armed security personnel onboard ships in the High Risk Area", (*for references visit Maritime Security link, Imo Documents*) in order to avoid delays and troubles while arriving, staying and departing from ports, offshore terminals, anchorage or roadstead located areas within the territory or under the jurisdiction of a port or a coastal State.

**4.2.2** We must request to maintain wide communication with the Administration and to liaise with the International Contact Centers according to the Best Management Practices (BMP5) in order to counter piracy in the High-Risk Areas of the Gulf of Aden, Indian Ocean and any other Region of High Risk, as determined by this administration.

## **4.3. Security personnel and weapons listed by PMSC.**

**4.3.1** , All Private Maritime Security Companies should send the UPDATED INFORMATION (ISO, Third party insurance, personnel, weapons list and procedures for the handling and inventory of weapons on board ships, transport, shipment and disembarkation) through the following website link: <https://certificates.amp.gob.pa/certificates/FrmAnualReport.aspx>

**4.3.2** The Private Security Companies (PMSC) authorized by this Administration shall ensure that the security personnel incorporated into the company and assigned to be on board the Panamanian flagged vessel, meets the requirements on paragraph 5 article 4 of Resolution No. 106-13-DGMM dated March 8, 2012 and additional requirements listed on Resolution No. 106-85-DGMM dated December 17, 2014.

**4.3.3** Every private security company, approved by this Administration, must have the certainty that the security personnel hired, is not included in the list of terrorists of the United Nations Security Council, at the website <https://www.un.org/securitycouncil/>

**4.3.4.** In cases where the security company embarks on eight (8) or more weapons per transit, the request to carry armed personnel onboard must have the approval of the owners, operators and/or charterers through an email of authorization stating that such number of weapons will remain onboard during the specific transit.

**4.3.5** The privately contracted armed security personnel has to be enrolled in Panama flag vessels as supernumerary in order to avoid any problem with the port and coastal state.

**4.3.6** From January 3<sup>rd</sup>, 2013, only the companies listed above are authorized to provide Security services onboard Panamanian vessels. **It is strictly forbidden to celebrate Joint Venture Contracts between unauthorized companies to provide services on board Panamanian flagged vessels, including security personnel and weapons. If any of this activity is carried out, the company would be responsible for any infringement.**

## **4.4. Piracy Reports.**

**4.4.1** On August 3<sup>rd</sup>, 2011 the Panama Maritime Authority together with the Marine Administrations of Liberia and the Marshall Islands signed a Declaration, affirming their commitment to share information provided to the Flag State related to acts of piracy or armed robbery to the International Maritime Bureau (IMB), which would allow to investigate and face with greater clarity the human costs involved in these criminal acts.

As part of the agreement, we are encouraging our ship owners/operators to complete an online survey <http://www.icc-ccs.org/seafarer-survey> for seafarers to understand the Human element on sailing through the High-risk waters of piracy and armed robbery. These surveys must be submitted directly to IMB.

**4.4.2** Pirates attacks are classified in four (4) categories:

- a. Attempt: vessels approached by a pirate skiff.
- b. Fired Upon: vessels shot at by pirate groups; pirates unable to board vessel.
- c. Boarded: vessels boarded by pirates, but not hijacked. This category also includes cases when an armed robbery has taken place.
- d. Hijacked: vessels over which pirates successfully gain control; crew is taken hostage.

**4.4.3** The Panama Maritime Authority requires all the Panamanian vessels that have undergone an attack / armed robbery / hijack, to send us application Forms (*for references visit Maritime Security link, Panama Piracy Report*) in the which must be completed by Ship-owners/Operators, Masters, Company Security Officer, and then submitted to the following addresses: [asp@amp.gob.pa](mailto:asp@amp.gob.pa). Please note these Forms must be forwarded as soon as possible in order to compile information and be able to create measures to protect our vessels against piracy attacks.

- a. Cases in which an attack (attempt) was suffered but did not turned into hijack (robbery/damages) PIRACY AND ARMED ROBBERY ATTACK REPORT FORM.
- b. Cases in which a Hijack took place PIRACY HIJACK FORM.
- c. *IMB Seafarers Survey Form B: Short Duration Incidents (Part A and Part B).*

**4.4.4** All the Private Maritime Security Companies already recognized with PMA authorization per transit or not must submit the enclosed PCASP Report, duly filled and signed with details of their service before/after the security teams disembark from the vessel through: <https://certificates.amp.gob.pa/certificates/FrmPiracyReport.aspx>. This information will be verified in the presentation of the Annual Report.
