# **H2.9.11 Precaution against Fire**

Main text of sub-paragraph -5 has been amended as follows.

The wording "high fire risk areas" in **2.9.11-2** and **-3**, **Part H of the Rules** generally means the places as specified below;

Sub-paragraph -7(2) has been amended as follows.

(2) The "similar spaces" means the machinery spaces other than the machinery spaces of category A.

### H2.9 Cables

## **H2.9.14 Supports and Fixing of Cables**

Sub-paragraph -2 has been amended as follows.

2 The wording "to be of flame-retardant" in 2.9.14-3(3)(a), Part H of the Rules means those clips passed the flame-retardant test in accordance with the standard *UL*94 (categories V-0, V-1, V-2) or equivalent thereto.
