Part C HULL CONSTRUCTION AND EQUIPMENT

Chapter 1 GENERAL

1.1 General

1.1.3 Ships of Unusual Form or Proportion, or Intended for Carriage of Special Cargoes

Sub-paragraph -5 has been added as follows.

5 The hull structural members of ships intended for the carriage of cargoes having moisture contents which exceed transportable moisture limit are to be in accordance with the requirements provided in this Part. In addition, the special considerations deemed necessary by the Society are to be taken into account.

Chapter 3 RUDDERS

3.9 Bearings of Rudder Stocks and Pintles

Paragraph 3.9.3 has been amended as follows.

3.9.3 Bearing Clearances

With metal bearings, clearances are not to be less than $d_{hs}/1000+1.0$ (*mm*) on the diameter.

 d_{hs} is the inner diameter of the bush.

If non-metallic bearing material is used, the bearing clearance is to be specially determined considering the material's swelling and thermal expansion properties. This clearance is in no way not to be taken as less than 1.5mm on the bearing diameter <u>unless a smaller clearance is supported</u> by the manufacturer's recommendation and there is documented evidence of satisfactory service <u>history with a reduced clearance</u>.

C1.1 General

C1.1.3 Ships of Unusual Form or Proportions, or Intended for Carriage of Special Cargoes

Sub-paragraph -4 has been added as follows.

- 4 "The special considerations deemed necessary by the Society" specified in 1.2.3-5, Part C of the Rules means to be in accordance with the following (1) or (2):
- (1) For ships intended for the carriage of nickel ore with a moisture content that exceeds the transportable moisture limit, the requirements specified in "Guidelines for the Safe Carriage of Nickel Ore"
- (2) For ships intended for the carriage of cargoes other than nickel ore, evaluation methods deemed appropriate by the Society

C25.2 Painting

C25.2.3 Corrosion Protection for Cargo Oil Tanks

Sub-paragraph -3 has been added as follows.

<u>3</u> With respect to 25.2.3(2), Part C of the Rules, the relevant IACS Unified Interpretation is to be applied.
