## Rule No.3030 June 2021AMENDMENT TO THE RULES FOR CARGO REFRIGERATING INSTALLATIONS

"Rules for cargo refrigerating installations" has been partly amended as follows:

### Chapter 6 TESTS

### 6.1 Tests at the Manufacturer's Works

### 6.1.1 Pressure Tests and Leak Tests

Sub-paragraph -3 has been amended as follows.

3 In general, pressure tests are to be carried out with water or oil and leak tests are to be carried out with air or suitable inert gases or any inert gas with a small amount of the refrigerant added to it. To implement the survey for the tests, in lieu of traditional ordinary surveys where the Surveyor is in attendance, the Society may approve other survey methods which it considers to be appropriate.

### 6.1.2 Performance Tests

Sub-paragraph -1 has been amended as follows.

1 Compressors, fans, primary refrigerant or brine pumps and their prime movers are to be tested for their performance. To implement the survey for the tests, in lieu of traditional ordinary surveys where the Surveyor is in attendance, the Society may approve other survey methods which it considers to be appropriate.

### EFFECTIVE DATE AND APPLICATION

1. The effective date of the amendments is 1 July 2021.

<u>The wording "the Society may approve other survey methods which it considers to be</u> appropriate" in **6.1.1-3 of the Rules** means survey methods which it considers to be able to obtain information equivalent to that obtained through traditional ordinary surveys where the Surveyor is in attendance.

#### 6.1.2 Performance Tests

<u>The wording "the Society may approve other survey methods which it considers to be appropriate" in 6.1.2-1 of the Rules means survey methods which it considers to be able to obtain information equivalent to that obtained through traditional ordinary surveys where the Surveyor is in attendance.</u>
