Rule No.4830 June 2022AMENDMENT TO THE RULES FOR RADIO INSTALLATIONS

"Rules for radio installations" has been partly amended as follows:

Chapter 2 SURVEYS

2.1 General

2.1.5 Preparation for Surveys and Others*

Sub-paragraph -5 has been added as follows.

5 In cases where it is necessary to replace any fittings, equipment, parts, etc. used on board, replacements are not to use any materials which contain asbestos.

2.2 Registration Surveys

Paragraph 2.2.1 has been amended as follows.

2.2.1 Submission of Plans and Documents for Approval*

<u>3</u> The following plans and documents are to be submitted to the Society for reference in addition to the approval plans and documents specified in the preceding -1.

Asbestos-free declarations and supporting documents

Paragraph 2.2.2 has been amended as follows.

2.2.2 Surveys*

 $\underline{1}$ After radio installations have been installed on board, a Registration Survey is to be carried out according to the requirements of the Rules.

2 Surveyors are to confirm that materials which contain asbestos are not being used.

Notice No.34 30 June 2022 AMENDMENT TO THE GUIDANCE FOR RADIO INSTALLATIONS

"Guidance for radio installations" has been partly amended as follows:

Amendment 1-1

Chapter 2 SURVEYS

2.1 General

2.1.5 **Preparation for Surveys and Others**

Sub-paragraph -3 has been added as follows.

<u>3</u> With respect to **2.1.5-5** of the Rules, surveyors are to confirm at periodical surveys that asbestos-free declarations and supporting documents are provided for any replaced or newly installed fittings, equipment, parts, etc.

2.2 Registration Surveys

Paragraph 2.2.2 has been amended as follows.

2.2.2 Surveys

<u>1</u> Requirements of the Registration Survey referred to in paragraph **2.2.2 of the Rules** are detailed below:

((1) to (15) are omitted.)

2 With respect to 2.2.2-2 of the Rules, surveyors are to confirm the asbestos-free declarations and supporting documents specified in 2.2.1-3 of the Rules.

Amendment 1-2

Chapter 2 SURVEYS

2.1 General

Sub-paragraph -2 has been amended as follows.

2.1.5 **Preparation for Surveys and Others**

2 Tests and measurement data taken by the radio inspectors within three *months* of the date of the survey, in general, may be acceptable are to be carried out at the times specified in (1) or (2) below. However, in cases where surveys are carried out in advance in accordance with 2.1.3 of the **Rules**, the test period is to be as deemed appropriate by the Society.

- (1) In the case of Periodical Surveys, the test period is within three *months* before or after the anniversary date of the next required Periodical Survey but not later than the date of completion of said survey.
- (2) In the case of Special Surveys, the test period is within three *months* before the date of expiry of the relevant certificate but not later than the date of completion of the Special Survey.

EFFECTIVE DATE AND APPLICATION (Amendment 1-2)

- **1.** The effective date of the amendments is 1 July 2022.
- 2. Notwithstanding the amendments to the Guidance, the current requirements apply to the surveys for which the application is submitted to the Society before the effective date.
