Reason for Amendment

With regard to the surveys for maintenance of class and installation registration currently required by the ClassNK Rules, no requirements are specified when the confirmation of the status of the ship by survey is deemed necessary in cases where the Society suspects the ship or installations of not being in continued compliance with the Rules and Regulations of the Society, and of not being properly maintained and operated by the ship owner.

Accordingly, relevant requirements were amended to clarify requirements related to the conducting of such surveys.

Outline of Amendment

Specified that the classed ships may be subject to “Unscheduled Surveys” when the confirmation of the status of the ship by survey is deemed necessary in cases where the Society suspects the ship or installations of not being in continued compliance with the Rules and Regulations of the Society, and of not being properly maintained and operated by the ship owner.
