### **Reason for Amendment**

Unscheduled surveys are specified in the ClassNK Rules as either surveys for the maintenance of class or the maintenance of installation registration. Such unscheduled surveys may be deemed necessary by the Society when it feels a situation exists which may adversely affect either its overall reputation as a classification society, or the reputations of any ships/installations it classes/registers, perhaps due to the classification/registration of a particular ship/installation no longer being considered appropriate for some reason. In such cases, the Society will notify the relevant shipowner of the need for such a survey, request that an application the survey be submitted, and then conduct the survey based upon said application.

It was not clear, however, how such surveys were to be treated or categorized, etc. Therefore, relevant requirements were amended accordingly for clarification purposes.

### **Outline of Amendment**

- (1) Clarified that unscheduled surveys are to be treated/categorized as a survey for maintenance of classification/registration.
- (2) Specified that reference is to be made to the Conditions of Service for Classification of Ships and Registration of Installations to clarify the grounds for conducting unscheduled surveys.
