Reason for Establishment and Amendment

Regulation II-1/3-5 of SOLAS prohibits the new use of asbestos containing materials after 1 January 2011 without exception.

Therefore, IACS adopted IACS Unified Interpretation (UI) SC249 in October 2011, which requires that an asbestos-free declaration be made to confirm that materials containing asbestos are not being used.

However, since the handling of asbestos by each country was unclear, Class NK's response to IACS UI SC249 was to provide technical information and issue inspection instructions while monitoring the responses of each country.

Since the handling of asbestos by each country has been clarified, relevant requirements are amended accordingly based on IACS UI SC249 as part of a comprehensive review of the ClassNK Rules.

Outline of Establishment and Amendment

- (1) Specifies that asbestos-free declarations and supporting documents are to be submitted as reference documents at Classification Surveys During Construction.
- (2) Specifies that surveyors are to confirm at Classification Surveys During Construction that materials containing asbestos are not being used in accordance with submitted asbestos-free declarations and supporting documents.
- (3) Specifies that surveyors are to confirm at periodical surveys that materials containing asbestos are not being used in accordance with submitted asbestos-free declarations and supporting documents in cases where onboard fittings, equipment, parts, etc. are replaced after a ship enters into service.
