Reason for Amendment

On 27 December 2021, ClassNK officially announced amendments to its Rules and Guidance for the Survey and Construction of Steel Ships Parts C and CS as well as amendments to its Rules and Guidance for the Survey and Construction of Passenger Ships. These amendments were based on the IACS Unified Interpretation (UI) SC161(Rev.2) (adopted in May 2021) regarding timber deck cargoes and were applicable to ships contracted for construction on or after 1 July 2022.

IACS, however, subsequently proposed a new version of UI SC 161(Rev.3) that has enhanced requirements for uprights to the IMO. The IMO, in turn, approved this new version of the UI as MSC.1/Circ.1653 at the 105th Session of the IMO Maritime Safety Committee (MSC 105) in April 2022.

Following this, IACS revisited UI SC161 to see what changes needed to be made to take into account MSC.1/Circ.1653. Since MSC.1/Circ.1653 was approved by the IMO prior the entry into force of UI SC161(Rev.2), IACS decided to withdraw UI SC161(Rev.2) altogether and combine its contents plus the aforementioned enhanced requirements for uprights into UI SC161(Rev.3), which would be applicable to ships contracted for construction on or after 1 January 2023.

Accordingly, the effective dates and applications of the Society's amendments based on UI SC161(Rev.2) are amended in accordance with UI SC161(Rev.3).

Outline of Amendment

Amends the effective date and application of the amendment with regard to the withdrawal of IACS UI SC161(Rev.2).
